Union Gap's Holiday Lighted Parade

Following are some general rules & suggestions:

- Line-Up on (first street, Not Main Street) headed South beginning at the Peppermint Stick Drive-In. Parade will then head North on Main Street.
- Equestrian units or any one with live animals must provide their own POOPER SCOOPERS. No Exception!
- Alcoholic beverages are forbidden on any float or vehicle, or on the person of any parade participant. Profanity is not allowed within the assembly or dispersal areas or on the parade route.
- Parade participants may neither mingle with nor accost parade spectators.
- Live broadcasts from vehicles or floats will NOT be allowed. Music is allowed with tasteful volume.
- Parade entrants must observe all applicable rules and regulations and follow all instructions from Police and Parade Officials. Parade Officials reserve the right to remove any entrants from the parade either prior to the parade or at any time during the parade.
- All units may be inspected for safety. Safety belts, fire extinguishers etc.

Your signature indicates your understanding of these rules and your desire to participate in this event. You certify that **all members of your organization taking part in this event have been notified of these rules.** In consideration of the acceptance of your entry, the sponsors and/or parade participants hereby identify and hold harmless the Citizens For Union Gaps Future, the City of Union Gap, officers or employees of either, as well as any volunteers assisting in this event, from any claim or demand for personal injury, death, or property damages which arise through or in connection with either sponsor or parade participant actions before, during or after any Union Gap Parades.
