The City of Union Gap invites separate sealed BIDS for the construction of the AHTANUM/MAIN I/S & RUDKIN RESURFACING IMPROVEMENTS, HLA Project No. 09047E, including the following approximate major quantities of work:

Resurfacing of approximately 1,600 LF of Rudkin Road and approximately 600 LF of Main and Ahtanum Road intersection by grinding approximately 1,300 SY of bituminous/asphalt pavement, 1,300 Ton HMA, 6 sidewalk ramp improvements, 23 manhole and valve box adjustments, 9 traffic signal loop replacements, painted pavement markings and other related work.

This contract has Twenty five (25) working days to complete the work.
